We now have insurance on the pool!!! The board was unable to get the additional insurance needed to rent out the pool house at this time. The price was a big factor and a Certificate of Occupancy was never obtained after the completion of the renovation last spring. The board is currently working on these items so that we can enjoy the entire pool area for the 2021 pool season.

We have a new lawn company for the neighborhood common areas (including pool & tennis court area)! They will cut Friday, April 3<sup>rd</sup>. The dead trees at the entrance of Phase One will also be removed in the next few weeks.
